I agree to pay the GCSSD the connection charges and fees as may be fixed by the governing body by resolution or ordinance. Additionally, I agree to pay a **\$150 deposit** for new accounts which may be refundable after 1 year of service in good standing at the discretion of the GCSSD or to be forfeited in the event of past due balances. The connection so made by the GCSSD, including the meter, shall always remain the property of the GCSSD, and the GCSSD shall have access thereto at all times. I will be bound by the rules, regulations, resolutions, or ordinances enacted now or hereafter by the GCSSD applicable to the Districts water system and waste management program. The undersigned hereby applies for water services and/or waste management from the GCSSD of Big Water, Ut for premise located at above mentioned address and hereby agrees:

1. To pay charges for such water service and waste management as are fixed from time to time by the governing body until such time as shall direct such service to be discontinued in writing, contacts, or by calling.
2. in the event of failure to pay water and waste management charges within the due dates fixed by the governing body or failure of the occupant of the premises to conform to the ordinances and regulations established by the governing body regulating the use of the water system and waste management services at its election pursuant to five days written notice of the GCSSD's intention mailed to the address of the responsible party, until all delinquencies and any re-connection fees imposed are paid in full or until any failure to conform to this ordinance and regulations issues thereunder is eliminated.
3. To be bound by the rules, regulations, resolutions, or ordinances enacted or adopted by the governing body applicable to GCSSD's water system and waste management.
4. In the event of collection to pay any reasonable attorney fees and costs of the court.
